Council of the City of Gulf Breeze, Florida, will hold a "Virtual" Special meeting and Public Hearing on Thursday, **September 14, 2020**, at **5:30 p.m.** utilizing communications media technology (CMT) as authorized by Governor DeSantis' Executive Order 2-69 on March 20, 2020, as extended by Executive Order No. 20-193 on August 7, 2020. The purpose of the "Virtual" Special meeting and Public Hearing is to establish a tentative millage rate of 1.9723 for tax year 2020 and to adopt a tentative budget for fiscal year 2021. 
