RESOLUTION NUMBER 18-2022

A RESOLUTION OF THE CITY OF GULF BREEZE, FLORIDA TO ADOPT A REVISED SCHEDULE OF AUTHORIZED POSITIONS FOR FISCAL YEAR 2022; PROVIDING FOR REPEAL OF CONFLICTING SCHEDULES; AND, PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, at its regular meeting on September 20, 2021, the City Council of the City of Gulf Breeze approved and adopted the City's Fiscal Year (FY) 2022 comprehensive budget; and

WHEREAS, the adopted budget includes staff salaries for FY 2022 for the positions; and

WHEREAS, on October 4, 2021, the City Council adopted Resolution No. 45-2021, approving a Schedule of Authorized Positions for FY 2022; and

WHEREAS, on February 7, 2022, the City Council adopted Resolution No. 03-2022 as the first amendment to the FY2022 Schedule of Authorized Positions; and

WHEREAS, on July 5, 2022, the City Council authorized the addition of two full-time Service Workers for the Parks Division; and,

WHEREAS, on August 15, 2022, the City Council authorized the removal of the Special Advisor from the General Government Department; and

WHEREAS, on August 15, 2022, the City Council authorized the Recreation Assistant – After School/Summer Camp position to be separated into two positions as follows: "Recreation Assistant - Summer Camp" with 28 seasonal positions and "Recreation Assistant - After School" with 10 part-time positions; and

WHEREAS, the City desires to amend the Schedule of Authorized Positions for Fiscal Year 2022 to reflect the changes in authorized position recited herein. This will be amendment number 2 and represents the final amendment to FY2022 Schedule of Authorized Positions.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GULF BREEZE, AS FOLLOWS:

SECTION 1. RECITALS.

The "Whereas" clauses set forth above are incorporated herein by reference.

SECTION 2. ADOPTION OF A REVISED SCHEDULE OF AUTHORIZED POSITIONS.

The City Council of the City of Gulf Breeze hereby adopts a revised Schedule of Authorized Positions for FY2022 by adding two full-time Service Workers to the Parks Division,

removing the Special Advisor position from the General Government Department, and reorganizing the Recreation Assistant - After School/Summer Camp position into separate categories as follows: "Recreation Assistant - Summer Camp" with 28 seasonal positions and "Recreation Assistant - After School" with 10 part-time positions, attached hereto as Exhibit "A".

SECTION 3. REPEAL OF CONFLICTING PROVISIONS

All schedules or parts thereof of the City that conflict with the provisions herein contained are, to the extent of such conflict, hereby superseded and repealed.

SECTION 4. EFFECTIVE DATE.

This Resolution shall take effect immediately upon its adoption.
