### **RESOLUTION NO. 25-2023**

A RESOLUTION OF THE CITY OF GULF BREEZE, FLORIDA TO ADOPT A REVISED SCHEDULE OF AUTHORIZED POSITIONS FOR FISCAL YEAR 2023; PROVIDING FOR REPEAL OF CONFLICTING SCHEDULES; AND PROVIDING FOR AN EFFECTIVE DATE

**WHEREAS,** at its regular meeting on September 19, 2022, the City Council of the City of Gulf Breeze approved and adopted the City's Fiscal Year (FY) 2023 comprehensive budget; and

WHEREAS, the adopted budget includes staff salaries for FY 2023 for the positions; and

**WHEREAS**, on September 19, 2022, the City Council adopted Resolution No. 38-2022, approving a Schedule of Authorized Positions for FY 2023; and

**WHEREAS**, on November 7, 2022, Amendment No. 1 to the Schedule of Authorized Positions for fiscal year 2023 was adopted by the City Council by Resolution No. 44-2022, funding one police officer position through the second quarter of FY2023 and increasing the classification grade for the Natural Gas Supervisor from 15 to 17; and,

WHEREAS, on January 17, 2023, Amendment No. 2 to the Schedule of Authorized Positions for fiscal year 2023 was adopted by the City Council by Resolution No. 01-2023, the City Council authorized the elimination of the Administrative Assistant from the Finance Department and authorized the funding of a Procurement Officer under the Finance Department with a grade classification of 13; and,

WHEREAS, on May 1, 2023, the City Council approved the addition of four seasonal Services Worker positions under the Parks & Recreation, Parks Division, to the Schedule of Authorized. Staff advised at the time of approval that a resolution would be brought back for consideration; and,

**WHEREAS**, on September 6, 2023, the City Council authorized the temporary funding of a Deputy Finance Director under the Finance Department with a grade classification of 26; and,

**WHEREAS**, the City desires to amend the Schedule of Authorized Positions for Fiscal Year 2023 to reflect the changes in authorized positions recited herein.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GULF BREEZE AS FOLLOWS:

#### **SECTION 1. RECITALS.**

The "Whereas" clauses set forth above are incorporated herein by reference.

# SECTION 2. ADOPTION OF A REVISED SCHEDULE OF AUTHORIZED POSITIONS.

The City Council of the City of Gulf Breeze hereby adopts a revised Schedule of Authorized Positions for FY2023 by authorizing the temporary funding of a Deputy Finance Director position within the Finance Department with a grade classification of 26, and the addition of four seasonal Services Worker positions under the Parks & Recreation, Parks Division, to the Schedule of Authorized, which is attached hereto as **Exhibit "A."** 

# SECTION 3. REPEAL OF CONFLICTING PROVISIONS

All schedules or parts thereof of the City that conflict with the provisions herein contained are, to the extent of such conflict, hereby superseded and repealed.

### SECTION 4. EFFECTIVE DATE.

This Resolution shall take effect immediately upon its adoption.
