

RESOLUTION NO. 69-2024

A RESOLUTION OF THE CITY OF GULF BREEZE, FLORIDA TO ADOPT A REVISED SCHEDULE OF AUTHORIZED POSITIONS AS AMENDMENT NO. 1 FOR FISCAL YEAR 2025; PROVIDING FOR REPEAL OF CONFLICTING SCHEDULES; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, at its regular meeting on September 16, 2024, the City Council of the City of Gulf Breeze approved and adopted the City’s Fiscal Year (FY) 2025 comprehensive budget; and

WHEREAS, the adopted budget includes staff salaries for FY 2025 for the positions; and

WHEREAS, on September 16, 2024, the City Council adopted Resolution No. 49-2024, approving a Schedule of Authorized Positions for FY 2025; and

WHEREAS, on December 4, 2024, the City Council approved an amendment to the Schedule of Authorized Positions for fiscal year 2025, creating the position of Assistant Director of Public Works as a pay grade 24 within the Public Works Department; and,

WHEREAS, the City desires to amend the Schedule of Authorized Positions as Amendment No. 1 for Fiscal Year 2025 to reflect the changes in authorized positions recited herein.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GULF BREEZE AS FOLLOWS:

SECTION 1. RECITALS.

The “Whereas” clauses set forth above are incorporated herein by reference.

SECTION 2. ADOPTION OF A REVISED SCHEDULE OF AUTHORIZED POSITIONS.

The City Council of the City of Gulf Breeze hereby amends the Schedule of Authorized Positions as Amendment No. 1 for fiscal year 2025 authorizing the creation of the Assistant Director of Public Works position as a pay grade 24 within the Public Works Department. The revised Schedule of Authorized Positions is attached hereto as **Exhibit “A.”**

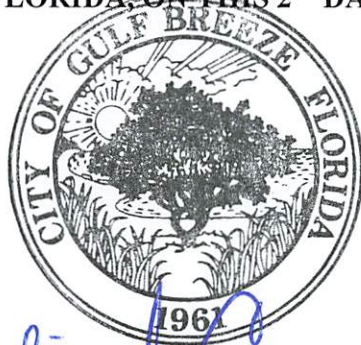
SECTION 3. REPEAL OF CONFLICTING PROVISIONS
