

RESOLUTION NO. 14-2026

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GULF BREEZE, FLORIDA, AMENDING THE FISCAL YEAR OCTOBER 1, 2025, THROUGH SEPTEMBER 30, 2026, BUDGET TO MAKE CERTAIN AMENDMENTS TO APPROPRIATIONS OF CITY FUNDS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, per Florida Statutes Title XII, Section 166.241, the adopted budget may be revised with a budget amendment approved by City Council in the same manner in which the budget was adopted. The resolution adopting the annual budget allows the budget to be amended by resolution, provided a corresponding funding source supports any additional expenditures. Transfers between funds and increases to a fund’s total budget are permitted by a resolution adopted by the City Council. The budget amendment increases or decreases the total amount of the adopted budget of each fund.

WHEREAS, Resolution No. 45-2025, adopted on September 15, 2025, authorizes the Fiscal Year 2026 budget and authorizes amendments to the budget by resolution.

WHEREAS, Resolution No. 03-2026 was the first budget amendment for Fiscal Year 2026, adopted on February 2, 2026.

WHEREAS, Resolution No. 14-2026 is amendment number two to the Fiscal Year 2026 annual budget as originally adopted.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GULF BREEZE, FLORIDA THAT:

The following expenditures were not included in the Fiscal Year 2026 Adopted Budget and, therefore, must be appropriated and added to the budget for the fiscal year ending September 30, 2026.

Change #02-26 – This amendment authorizes an increase in appropriations above the originally budgeted amount to fund the total contract value associated with the bid award for the West Water Plant Upgrades project.

Change #03-26 – This amendment authorizes the appropriation of funds for the purchase of a second ADA-accessible portable restroom trailer for the Parks Department.

Change #04-26 – This amendment authorizes funding for the third and final year of the PipeSuite Distribution Pipeline Compliance Service Package contract for the Natural Gas Department.


